4. The motion should be seconded and a majority of the members present must adopt, by <u>roll call vote</u>, the motion.

5. Prior to entering executive session the presiding officer should announce the approximate time of the session (45 minutes) and that the body will not reconvene afterwards.

6. The minutes should reflect all of the foregoing.

CONSENT JUDGMENT

This matter having been reported as settled, the parties hereby agree to the entry of the following consent judgment:

1. The Defendant City Council shall, within 30 days from the date of this order, adopt an ordinance in substantial form as the ordinance attached as Exhibit 1 to this judgment rezoning of Plaintiffs' property from R-1 to R2 (as recommended by the Mobile Planning Commission). Said rezoning shall be subject to the condition that the property may only be used for the development of a subdivision consisting of not more than 23 single family homes (with a green space located on one of the lots depicted on the site plan as lots 10 through 15). Further, the homes shall generally conform to the materials and specifications set forth in the attached Exhibit 2.

2. The Plaintiff shall, within 30 days from the date of this order make application to the Planning Commission for a subdivision and Planned Unit Development consistent with the approvals previously granted by the Planning Commission and consistent with the conditions set forth in paragraph one of this order.

3. The-Plaintiffs shall not pursue a connection of the 50' ROW hammerhead to the street to the north, and shall comply with all other conditions that may lawfully be Imposed by the Planning Commission.

Neighborhood Plan – 24 lots



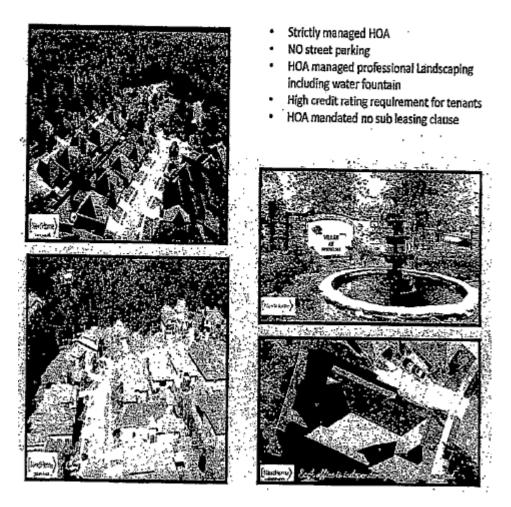

The classification of said property is hereby changed from R-A, Residential-Agricultural District, to I-1, Light Industry District, and it shall hereafter be lawful to construct on such property any structures permitted by the Ordinance of May 16, 1967, commonly known as the Zoning Ordinance and to use said premises for any use permitted by the terms of said Ordinance in I-1, Light Industry District, provided, however, that the plans for any structure or building sought to be erected on said property shall be in compliance with the building laws of the City of Mobile, and that any structure shall be approved by the Building Inspector of the City of Mobile, and that any such structure be erected only in compliance
